In accordance with a resolution passed by the Honorable Board of Commissioners of Berrien County, Michigan on March 25, 2021, which declares a state of emergency for Berrien County, all local municipal subdivisions, and all public bodies in the County, which permits the extension of the state of emergency issued on March 25, 2021 through June 30, 2021. This enables the continuation of virtual public meetings in a manner consistent with the current Open Meetings Act modifications on the dates publicly posted designed to help prevent the spread of Coronavirus Disease 2019 (COVID-19) and allow electronic conferencing technology to meet and conduct business.

The Bridgman City Council will hold its regularly scheduled City Council meeting on **Monday, May 17, 2021** beginning **at 6:30 p.m. both in person** at City Hall, 9765 Maple Street, Bridgman, MI **and remotely** by means of **electronic conferencing**.

Members of the public wishing to participate in the meeting through electronic means will have access to the meeting through the following methods:

Members of the public wishing to attend may connect or call in before the meeting starts and wait in a “virtual waiting room” until the meeting is ready to begin. Audience members will be able to hear the meeting and will be able to see video shared by Council Members or staff or presentations if their means of connection allow. Audience members will have their microphones muted when they enter the meeting and will not be able to share images.

Public comments will be taken, as at every public meeting. Due to the remote meeting format, the following procedures will be used to facilitate public comment during the meeting:

- All public comment for items not on the agenda will be taken at the Public Comment section of the Agenda, located at the end of the meeting.
- Computer/tablet/smartphone audience: To indicate you wish to make a public comment, utilize the “Raise Hand” function by selecting “Manage Participants” on the bottom of your dashboard then select the “More” button in the bottom right-hand corner. The moderator will call your name aloud and unmute your connection so that you can comment. After your comment, your connection will again be muted.
- Phone-in audience: To make a public comment, push *9, which will be visible to the moderator in the same way as “Raise Hand” for participants using other devices. You will be placed in the queue for Public Comment. The moderator will announce the last two digits of your phone number for recognition (more digits if needed to distinguish between attendees with similar phone numbers) and unmute you so that you can speak. After you speak, your connection will again be muted.
- Please keep public comments concise.
